



## **Member Committee's**

Hartlepool Council became a unitary authority in April 1996, having previously been part of Cleveland County Council. It is the smallest of five small unitary authorities in the Tees Valley sub-region and in population terms is one of the smallest unitary authorities in the country. It has a net revenue budget in 2016/2017 of £77m.

It has 33 Councillors. The political balance is as follows:-

The Council moved to a Committee System of governance, in May 2013, followed a comprehensive public consultation exercise and referendum and at the Extraordinary Council meeting held on the 2 May 2013, Councillor Christopher Akers-Belcher was appointed as the Leader of the Council.

The Council also has two neighbourhood consultative forums serving the 'north and coastal' and 'south and central' areas of the town. All councillors are represented on one of these consultative forums, the remit of which includes the provision of Face the Public events for each of the Policy Committee chairs.

The Council has a detailed written constitution, which includes decision-making procedures and a delegated decision-making scheme.
