<p><b>To carry out Planning, Teaching and Class Management: to teach allocated Pupils by planning their teaching to achieve progression of learning through:-</b></p>		
<ul style="list-style-type: none"> <li>identifying clear teaching objectives and specifying how they will be taught and assessed;</li> <li>setting tasks which challenge pupils and ensure high levels of interest;</li> <li>setting appropriate and demanding expectations;</li> <li>setting clear targets, building on prior attainment;</li> <li>be aware of and make provision for pupils who are AEN/SEN, very able, LAC or who have other particular individual needs;</li> <li>providing clear structures for lessons maintaining pace, motivation and challenge;</li> <li>making effective use of assessment and ensure coverage of programmes of study;</li> <li>ensuring effective teaching and best use of available time;</li> <li>maintaining discipline in accordance with the school's procedures and encouraging good practice with regard to punctuality, behaviour, standards of work and homework;</li> <li>using a variety of teaching methods to: <ul style="list-style-type: none"> <li>i. match approach to content, structure information, present a set of key ideas and use appropriate vocabulary</li> <li>ii. use effective questioning, listen carefully to pupils, give attention to errors and misconceptions</li> <li>iii. select appropriate learning resources and develop study skills through library, ICT and other sources;</li> </ul> </li> <li>ensuring pupils acquire and consolidate knowledge, skills and understanding appropriate to the subject taught;</li> <li>evaluating own teaching critically to improve effectiveness;</li> <li>ensuring the effective and efficient deployment of classroom support;</li> <li>liaise with the subject leaders/senior leaders to ensure the implementation of school and curriculum policy and best practice.</li> </ul>

- assess and record pupils' progress systematically and keep records to check work is understood and completed, monitor strengths and weaknesses, inform planning and recognise the level at which the student is achieving;
- undertake assessment of pupils as requested by examination bodies and school procedures;
- prepare and present informative reports to parents;
- undertake assessment of pupils and participate in the school's system reporting to parents;

- contribute to the development, implementation and evaluation of the school's policies, practices and procedures in such a way as to support the school's values and vision;
- work with others on curriculum and/or pupil development to secure co-ordinated outcomes.

#### **Pastoral Duties:-**

- promote the general progress and well-being of individual pupils;
- contribute to the preparation of action plans and progress files and other reports;
- alert appropriate staff to problems experienced by pupils and make recommendations as to how these may be resolved;
- communicate, as appropriate, with parents of pupils and persons or bodies outside the school concerned with the welfare of individual pupils, after consultation with appropriate staff;
- contribute to PSHE and citizenship and enterprise according to school policy.
