#### Part A

The following criteria (experience, skills and qualifications) will be used to shortlist at the application stage:

## **Essential**

- Relevant industry or professional qualification in subject area or evidence of professional experience.
- Teaching qualification (Bed, Cert Ed or equivalent)
- Level 4 Literacy/ Numeracy/ESOL qualification/ experience of Family Learning as appropriate (for specialist areas).
- Assessor's and verifier's awards or a commitment to achieving them within 12 months (for assessors for apprenticeships and other workplace learning programmes).
- Experience of coaching and development of colleagues.
- Innovation in teaching, learning and assessment including e-learning with a consistent track record of observations at good or better.
- Good understanding of the expectations of Ofsted and analysing the key strengths and areas for improvement in a curriculum or other aspect of the Common Inspection Framework.
- Experience of participation in moderation (internal and external).
- The ability to organise and prioritise.
- Experience of planning and delivering staff development to drive innovation in teaching, learning and assessment.
- A commitment to equality and diversity and an understanding of its promotion in teaching, learning and assessment.
- Highly developed written communication skills.

#### **Desirable**

- Qualified Teacher, Learning and Skills status.
- Experience of supervising other staff.
- Experience of the supervision of volunteers and integrating them into the planning and delivery of sessions.
- Experience of undertaking observation of teaching, learning and assessment
- Very good IT skills.
- Good understanding of the funding methodology and its implications for curriculum development and delivery.
- Driving licence and use of a car.

#### Part B

The following criteria will be further explored at the interview stage:

- The ability to analyse and interpret performance statistics.
- Experience of team leadership and an effective contribution to teams.
- Demonstrate an understanding of the self-assessment process and its contribution to performance improvement.
- Highly developed oral communication skills.

- Supporting colleagues to become outstanding in teaching, learning and assessment, including an up to date knowledge and experience of e-learning.
- Experience of using observation of teaching, learning and assessment data and other sources to identify priorities for development.

## Access to HE:

- Experience of the UCAS application process and supporting learners through the application process.
- Understands the principles of the efficient and effective planning of complex programmes of learning.

#### **ESOL** and Maths:

- Understanding of the organisation and planning of learner programmes in these areas.
- Experience and understanding of JCP expectations.

# **English and Family Learning**

- Understanding of the organisation and planning of learner programmes in these areas.
- Experience and understanding of JCP expectations

# Dyslexia, LLDD and Learner Support

- Understanding of the needs of learners on specialist programmes
- Knowledge and understanding of the assessment for and promotion of learner support across the whole service

## Community Learning

- Experience of working with community based organisations
- Ability to undertake planning and timetabling activities in support of manager
