Part A: Application Stage

5	Ability to demonstrate emotional resilience in working with challenging behaviours
6	Experience of assisting in the administering, assessing and marking of tests
7	NVQ Level 2 or 3 for Teaching Assistants or equivalent qualification or experience
8	Level 2 Basic Skills (Literacy and Numeracy) or equivalent competency
9	Experience of delivering or supporting learning for children with ASD
10	Specific interest in developing the extended curriculum

10	'Team Teach' certification or training
11	First Aid Training

8	Committed to achieving further professional development
