#### Job Purpose

Carry out monitoring /audit visits to ensure compliance related to fire, asbestos, electrical safety, gas, lift safety and water hygiene.

#### The key roles of this post will include:

- 1. Support the Compliance Manager on the development and implementation of policies and procedures to ensure that all buildings within the client's portfolio are operated and maintained in accordance with all relevant current statutory legislation.
- 2. Carry out a programme of compliance audits / inspections on buildings within the client's portfolio to ensure policy commitments, KPI's and relevant legislation are met.
- 3. Support the Fire Safety Adviser to ensure fire safety is managed appropriately on all relevant buildings.
- 4. Assist in the development of Fire Safety Action Plans and Fire Emergency Plans where required.
- 5. Deliver fire safety training on the content of the Fire Safety Policy and Management Plan and to close out fire safety actions.
- 6. Assist in the investigation and reporting on all fire incidents throughout the client's premises.
- 7. Support the Building Safety Coordinator in overseeing the safety of designated buildings and coordination of post Grenfell recommendations and requirements.
- 8. To keep up to date with legislative changes and ensure compliance with safety requirements during all upgrading and refurbishment of buildings.
- 9. Support the Compliance Team in the completion of action plans and follow up work.
