## **Role Responsibility**

To prepare, cook and serve meals following the weekly menu prepared by the Head Cook. To assist the Head Cook in the preparation and serving of food. To ensure that washing up and clearing away of all kitchen utensils, equipment and serving crockery and cutlery is completed at the end of each shift.
