# The role of Internal Audit

The role of internal audit is to provide independent assurance that an organisation's risk management, governance and internal control processes are operating effectively.

An Internal Auditor has a professional duty to provide an unbiased and objective view and must remain independent from the operations they evaluate.



To be effective, the internal audit function must have qualified, skilled and experienced people who can work in accordance with the Public Sector Internal Audit Standards (PSIAS).

Internal auditors deal with issues that are fundamentally important to the success of the organisation. They look beyond financial risks and statements to consider wider issues such as the organisation's reputation, growth and impact on the environment.

The assurance part of an Internal Auditor's work involves telling managers and other key stakeholders how well the systems and processes designed to keep the organisation on track are working. Internal Audit also provide advice and consultancy support to management and other key stakeholders to help to improve systems and processes where required.

#### **The ICT Auditor**


An ICT auditor is responsible for analysing and assessing an organisation's technological infrastructure to identify problems with internal controls, risk management and compliance with internal policies and legislation, helping to ensure that systems and processes run accurately and efficiently.

An ICT auditor also identifies any ICT issues that fall under the audit, specifically those related to security and risk management. ICT auditors are responsible for communicating their findings and offering solutions.

#### **Pre-progression**

You will now be CISA qualified and through continuous professional development maintain a current ISACA membership. You will report directly to the Principal Auditor – ICT Specialist and be responsible for delivering on a range of ICT audits across our clients.

# **Roles in Internal Audit and Corporate Fraud**

- Internal Audit Assistants will work closely with our Senior Auditor in the delivery of internal audit plans and provide support for reviews.
- Senior Auditors will support Principal Auditors and Audit Managers in the delivery of internal audit plans and act lead auditor for specific reviews.
- **Principal Auditors** will support the Audit Managers in the development and delivery of the internal audit plans and act as lead auditor for specific reviews.
- Audit Managers are responsible for the management and direction of the audit team and support the Chief Internal Auditor and Corporate Fraud Manager in the development and delivery of the service's aims and objectives.
- Chief Internal Auditor and Corporate Fraud Manager is responsible for providing an annual opinion on the organisation's governance, risk management and internal control arrangements.
- ICT Auditors will will support the Principal Auditor IT Specialist in the delivery of IT assurance audits and provide advice and support on IT related risks, governance and control issues for a number of clients.
